## 2. COMPOSITION / INFORMATION ON INGREDIENTS

Liquid enzyme preparation, Cellulase, Pectinase IUB 3.2.1.4 / EINECS 232-734-4 / CAS 9012-54-8

#### 3. HAZARDS IDENTIFICATION

Repeated inhalation of enzyme aerosol may cause sensitisation and will cause allergic type responses in sensitised individuals.

## 7. HANDLING AND STORAGE
